

PRIVACY POLICY

Welcome to the Arbortech Chip Bodies website at <u>www.Arbortechchipbodies.com</u> (the "Website").

This website is operated by Stahl/a Scott Fetzer Co. d.b.a. ARBORTECH ("Company" or "Arbortech"). We are committed to service in the United States. Arbortech are the primary controllers of your personal information provided or collected by the Company.

ARBORTECH values your rights and respect your concerns regarding privacy. We have created this Privacy Policy to let you know how ARBORTECH collects, uses and how we protect the information that is collected and used by the Company. This Privacy Policy works and should be read in conjunction with the <u>Terms and Conditions of Use</u> (the "Terms and Conditions") but does not modify or supersede them. Terms which are capitalized but not defined herein shall have the meaning ascribed to them in the Terms and Conditions.

1. ARBORTECH Collection of Your Information

In the course of using the Website, ARBORTECH may collect information from you in three ways, from your input, from third party sources and through automated technologies. The information we collect will consist of:

- Contact details, examples include your name, e-mail address, postal address, and other information to conduct business with you ("*Personal Information*").
- Payment information, such as a credit or debit card number.
- Account login credentials, such as usernames and passwords.
- ARBORTECH also may collect certain non-personally identifiable information when you visit many of our Web pages such as the type of browser you are using (e.g., Internet Explorer, Chrome, Firefox, Safari), the type of operating system you are using, (e.g., Windows, Chrome OS, Android or Mac OS), the domain name of your Internet service provider (e.g., AT&T, Verizon, Time Warner Cable, Comcast, Earthlink), aggregate data about the number of visits to the Website and/or aggregate data about the pages visited (collectively "*Aggregate Data*").

2. How ARBORTECH Uses the Information

ARBORTECH may use the Personal Information that it collects to offer you other products or services that ARBORTECH believes may be of interest to you. The Aggregate Data and Personal Information may be transferred, distributed or sold as part of ARBORTECH or its assets.

3. Disclosure of Information

Disclosure of Your Information

We may disclose personal information that we collect, or you provide as described in this privacy policy:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by us about our Website users is among the assets transferred.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.



- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce or apply our terms of use and other agreements, including for billing and collection purposes.
